And while we're on the dog subject, please remember that *all* dogs must be on a leash while being walked in CPW. Not only is it safer (not every dog, or person, welcomes a visit from your dog; even the gentlest dog can act aggressively if they are not comfortable with other dogs) but it also helps cats feel safer in their own yards when dogs aren't traipsing through. Off-leash times are limited to the parks, and even then only when no other people or pets are in the vicinity. And don't forget you still have to clean up after Fido so keep a watchful eye out while he's playing!

Niwot on the Rails

The history of Niwot is being featured at the Longmont Museum and Cultural Center at 400 Quail Rd., from March 26-May 22. The exhibit, which is sponsored by the Niwot Historical Society, Niwot LID Advisory Committee, NBA Historic Projects Fund and the Left Hand Valley Courier, traces the history of a community that has changed greatly over time but that retains a self-reliance and a character all its own. Tree Sculpture Park Update

Two years ago when CPW approached the Local Improvement District with a landscape design based around the Tree Carvings on Niwot Rd., we never imagined it would evolve into the concept it is today. And it's a concept the whole town is rallying around. The latest word from the committee is that a grant has been submitted to Boulder County Great Outdoors (BOGO) for planning funds, which requires pledged money from Niwotians as well. If those funds are granted, the planning will begin in earnest and a second grant will be submitted later this year for development funds (which will also require pledge money). If all goes well, work would begin in spring of 2012. Although the entire Niwot area will benefit from such a project, CPW residents in particular will have a direct benefit. Not only will much of our dead open space area become beautified, but we'll be only a stone's throw from what will probably become a well-known and esteemed cultural site. Many thank to CPW president Dean Carpenter for being one of the major players on the town's committee for this project.

Don't Forget To Get Approval!

As everyone homeowner or resident at CPW should know, being part of the CPW community means following the Bylaws, CC&Rs and Standards and Guidelines (aka Rules and Regulations). Per those rules, homeowners are required to submit requests for all exterior changes or improvements to the board for approval. Again, this applies to all exterior changes or improvements, whether that improvement is a true change or simply an update to something existing. So whether you're replacing a fence, or windows, or the roof, painting your exterior, or building or replacing a deck, changing to stucco from wood siding, or you want to build a shed, you need to submit a request for approval. If you need clarification on this rule or how to go about submitting a request, don't hesitate to talk to Sharon or any board member. And please, don't be intimidated by this rule, the board is pretty openminded when they consider requests.
